What would you like to say about the issue?

We moved to Binghill Park in 1982, attracted by the proximity of the primary school and the wonderful views to the rear of the house. I note the proposals for the Milltimber primary school site and see that there are no current firm plans to progress with developments there.						
While it is designated a brownfield site, the acreage of the school is predominantly green! Over the greenery and over the single storey school building, Binghill Park residents enjoy pretty uninterrupted views over to the hills to the south of the River Dee.						
f there are to be houses, can one assume these will be single storey constructions? That said, Milltimber, as the council is no doubt aware, is sadly short of open green spaces. As I know well, many children deploy the school grounds, out of school hours, as a venue for play and exercise. It would seem to me- and especially in view of the looding worries for housebuilding on the site- that a much better alternative would be to convert the site into a small park with play area, thus enhancing the Milltimber area at low cost to the council. I do hope this option can be considered in due course.
