What would you like to say about the issue?

I feel Cove is being over developed, originally a small close knit fishing village, it is no longer recognizable. The local facilities are already inadequate for the existing population, the roads were never designed for the high volume of traffic and what was once green open space is being eroded and lost.					
Old Coast Road is a narrow back road which struggles with the existing traffic at peak times, narrowing at the bend towards Cove Rangers. This making it a bottle neck with traffic having to reverse at times to allow two way traffic .The majority of vehicles being "through" traffic coming from out with Cove using Old Coast Road as a short cut or rat run.					
Constructing housing schemes within Cove will only add to the congestion, density, put more pressure on the roads and facilities and leave limited green open spaces to be enjoyed by the residents and wildlife.					
The fishing village and community of Cove will be lost forever as with other surrounding villages, ruined, over developed with no identity.					

What change would you like to see made?

A halt to the construction of housing schemes in and around Cove, an improvement to the roads and infrastructure and better facilities.
