What would you like to say about the issue?

On behalf of the staff at Torry Medical Practice (TMP) and the wider Torry Community we would like to request that the whole site of the Former Torry Nursery School on Oscar Road directly adjacent to the existing Torry Neighbourhood building be formally reserved for health and social care ie the expansion of our existing building and the formation of a health and social care hub and working gardens.

Torry Neighbourhood Centre was opened in 2003, accommodating 3 branch surgeries, their admin needs were to be met not in Torry but in each practices principal buildings within the City. Room was also allocated to podiatry, dietetics, physiotherapy, OT and social work. Torry Medical Practice took over Carden's branch surgery in 2006, at this time there were just over 3000 patients on their list, Holburn remains at Torry with 1500 patients. Torry now has over 7000 patients. The building in addition to its original requirements now houses not only the practice district nurses but a large direct delivery care team, has a growing presence from substance misuse and all TMPs administrative needs have had to be accommodated on site not to mention the increase numbers of staff we have had to employ to deal with our increasing practice list size.

Staff at TMP are working in a building totally unfit for purpose. Cramped conditions, lack of storage space, hot desking and doubling up to deal with lack of clinical rooms and a reception that cannot offer adequate space to accommodate staff or offer appropriate levels of confidentiality when dealing with patients directly and over the phone. These cause unnecessary stress to our staff on a daily basis and a less than satisfactory service to our patients. Given that Grampian Primary Care has huge recruitment and retention issues it is vital that we strive to remove difficult working conditions in a hope of keeping a highly motivated and experienced primary health care team (PHCT). These are all immediate needs but it is also vital to look to the future needs of our practice.

Modernisation of general practice is essential for its survival. Our patients are becoming ever more complex medically and socially but also more demanding due to a combination of government health campaigns, government access promises, growing risk aversion, plummeting self care, obesity, poor diet, lack of exercise. Lack of robust family networks and improved employment rates for women have eroded our care for elderly relatives which has unfortunately been replaced by a poorly funded care system, unfit for purpose. To meet these needs greater diversity within the PHCT is necessary. This requires additional staff to enhance skill mix over and above what we have now. At present we are able to do little more than firefight on a daily basis.

Torry has an approx population of 10,000 patients and due to ongoing re-zoning Directives within NHS Grampian there will be increasing pressure on Torry Neighbourhood Centre to take on these patients, this is frankly impossible given our present working conditions. To then presume you can increase the population of Torry yet further (Victoria Road Site, Craiginches site, Abbey Road development not to mention possible development in Abbotswell Roadand the Waterfront) and expect them to receive medical services within their geographical community whilst not unreasonable will not be possible and demonstrates a lack of foresight and planning that is frankly unacceptable and would undoubtedly lead to a crisis in care with the risk to the sustainability of our practice.

Modernization requires vision, planning and faith beyond all our terms of office but without this and adequate funding we employ sticking plaster polices to deal with heart attacks and cancerous growths.

What change would you like to see made?

We would like to see this site protected for health and social care development. Development of this nature at this site in Oscar Road ie the expansion of our existing building and the formation of a health and social care hub and working gardens, offers an essential solution to our present problems and an valuable opportunity to deal in part with our growing population's health needs, health and social inequalities and the ever desirable regeneration of a community.
Developing housing would remove this option and place a further unacceptable burden on our practices ability to deliver essential medical services let alone allow for future development.
