

OBJECTION TO SITE OP52 MALCOLM ROAD, PETERCULTER, ABERDEEN

I object to the proposal as listed above. Any further development on or near to Malcolm Road is not possible due to the fact that the road is not of a standard required for a road with such heavy use. Malcolm Road is extremely dangerous, and it has been the scene of a number of serious Road Traffic Accidents over the years. Grampian Police regularly carry out speed checks along this very stretch of Malcolm Road, due to the danger to pubic safety posed by speeding motorists. The volume of traffic has dramatically increased in recent years due to the significant number of commercial office developments completed in Westhill. Additional traffic as a result of new housing would only add to the problem.

Malcolm Road is also a concern for pedestrians. There is currently only a footpath on the east side of Malcolm Road up to its junction with Bucklerburn Road. This long stretch of footpath is very narrow in areas and could not be widened due to land ownership and several buildings are close to the back of the pavement. The road is also narrow at this point and it is impossible for two HGVs to pass each other without one slowing to a stop. Persons who need to walk north of Bucklerburn Road are forced to cross to the west side of Malcolm Road. This is a hazardous crossing point due to the poor visibility either way along Malcolm Road and is made worse by the speed of vehicles at this point. There have been issues with natural drainage in the area for many years due to the filling in of ditches and Malcolm Road regularly floods at the junction with Bucklerburn Road. Any further development would exacerbate the problem. Also, the public sewer on Malcolm Road is at capacity and could not cope with additional connections.

What change would you like to see made?

OP52 should be removed from the Proposed Aberdeen Local Development Plan and kept as part of the Green Belt.
