## What would you like to say about the issue?

I would like to object to the proposed plan for the above named site, on which it is intended to build 150 new houses. The stationfields area has an abundance of deer and other wildlife which can be seen daily and this would undoubtedly be impacted by the proposal. It also contradicts the cauncil statement regarding the protection and conservation of natural environment and wildlife. I believe that the coast road leading to langulytes road, in addition to the roundabout at wellington road, would not cope with the increased volume of traffic. There will already be a significant increase in traffic due to the development at the bottom of St Filtricks Road.

## What change would you like to see made?

I would like to see the council leaving Stationfields site unoccupied as it is! There is no need for housing development in that area, particularly with the development plans for the Lairston area. In addition, as a local resident I do believe that the doctor surgery and small cooperative store would struggle to cope with the increase in residents.
