Most pupils in Lochside Road and adjacent streets will be closer to Greenbrae. Access to Glaslieburn Primary School for any pupil travelling on foot from either "area of land" would require crossing the very busy Scottstown Road at its junction with Jeamond Drive. This is potentially a safety issue. Traffic is very heavy at this junction at most times of day, but especially around the school run.<br><br>Pupils travelling from Greenbrae are more likely to be transported by car by parents concerned about their small children crossing Scottstown Road. Generally the further walking distance would also increase the likelihood of car travel. This is surely undesirable in a climate crisis, but also a real concern for residents on Newburgh Road where most parents drop off their children by car. The car park at Glaslieburn Primary School is entirely unsuitable for drop off, and e-mails are regularly sent by the school to parents to discourage the practice in the strongest possible terms. E-mails are also regularly sent about issues relating to Newburgh Road traffic to the rear of Glaslieburn Primary School. This would likely be exacerbated by additional families driving from Duford. I imagine similar is true in Glaslieburn Avenue.<br><br>Without detail explaining the rationale of the proposal, I assume this is because of the oversubscription of Greenbrae. ##### **7.11.22 - Comment**

Good afternoon,

As a parent of a pupil at Glashieburn Primary School I was recently sent a letter with today's date in relation to the proposal to amend the catchment area for certain Dubford residents. This called for consultation responses.

It is difficult to see how a proposal which provides no meaningful data would facilitate meaningful consultation responses.

How many pupils are enrolled at Greenbrae? How many pupils are enrolled at Glashieburn? What is the current capacity of each school? How many pupils would transfer from Greenbrae to Glashieburn? Which specific roads are covered by the proposal (instead of "an area of land")? What are the projections for school enrollment over the next few years? How do you intend to deal with any associated traffic issues?

Surely answers to the above questions already contained within the proposal would have facilitated a better response to the consultation. This should be data already within the possession of Aberdeen City Council. **I would encourage you to re-issue your proposal with a map, the above data, and a more detailed explanation of the rationale for the proposal.**

It is troubling that the likely cause for this proposal is the insufficient size of Greenbrae Primary School due to new developments on both sides of the A92. It was noted at the consultation phase of the new Dubford development at Shielhill (Cala/Barratt/Scotia) that Greenbrae had limited capacity. It seems a failure of the Council to adequately plan for the additional development and require of these developers to commit to build a sufficiently large extension of Greenbrae to account for additional capacity required. However, this is an assumption. An assumption required because of the absence of detail or explanation of the reasoning behind the proposal.

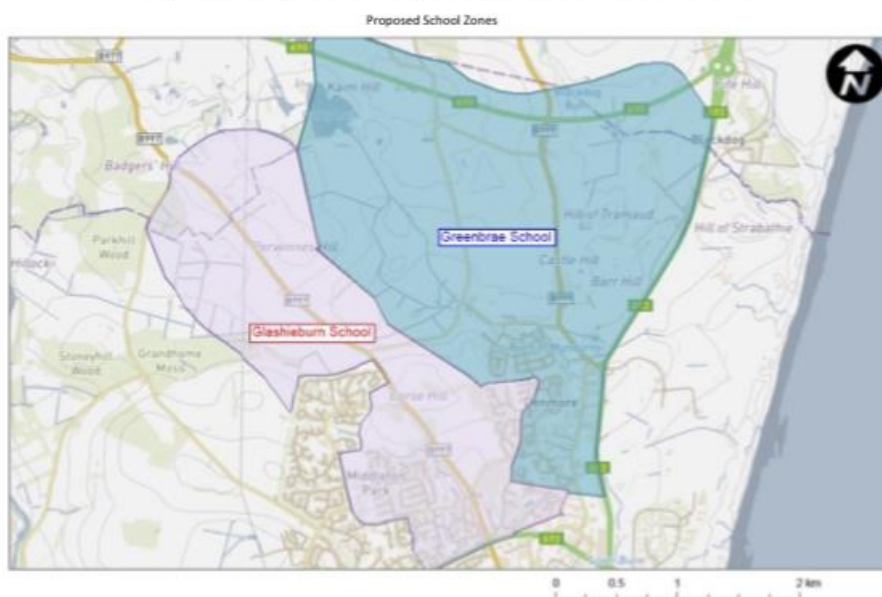

### NE1 - Green Belt

Development in areas defined as Green Belt on the Proposals Map will not be supported. Exceptions to this general presumption will only be supported where the proposal:

- is directly associated with and required for agriculture, woodland or forestry; or
- is for leisure or recreational uses compatible with an agricultural or natural setting; or
- is for the extraction of minerals or quarry restoration; or
- is associated with existing activities in the Green Belt and is within the boundary of that activity, is small-scale, does not significantly increase the intensity of the activity and the proposed built construction is subordinate to what already exists (including extensions to existing dwellings); or
- is directly associated with essential infrastructure such as telecommunications, electricity grid connections, transport proposals identified in the Plan or roads planned through masterplanning of sites, if they cannot be accommodated anywhere other than the Green Belt; or
- is related to the generation of renewable energy (wind turbine, solar farm, or hydro scheme) and/or heat; or
- is for a dwelling house to replace a dwelling house. This will be on a 'one for one' basis for development of a similar scale within the same footprint or existing curtilage of the site. This may be applicable to vacant properties in poor condition. All applications will be considered on a case by case basis; or
- is for the appropriate change of use of a building with a historic or architectural interest that makes a worthwhile contribution to the landscape character of the Green Belt; or
- is for a conversion/ rehabilitation scheme of a historic building. If extending, the original building will remain visually dominant to the new extension, the design and siting of the extension will be sympathetic in terms of massing,

### 14.11.22 – Response

Thank you for your email.

We are required to ensure that all areas of land within Aberdeen are covered by a school catchment area, including areas of land which have not been developed, and where there are no plans to build any houses.

The Greenbrae School and Glashieburn School catchment areas already include large areas of land to the north which have no housing on them (as shown in Map A of the proposal document), so the proposal we are consulting on does not change this. The proposed changes to the school catchment areas only affect the areas of established housing shown in

Map C, which we are proposing will move from the Greenbrae School catchment to the Glashieburn School catchment. We are not proposing any changes to the areas of undeveloped land to the north and there is no suggestion within the proposal that these will be developed in the future.

I hope this helps clarify things but please let me know if I can help any further.

Dear Sir/Madam

I write regarding the proposed rezoning for Greenbrae Primary School and the residents of Denmore Park (known as Lochside to locals)

Certain houses in Lochside back onto Greenbrae School playing field, literally a stones throw away. No houses on the entire estate are further than a 5 minute walk from the school, and there are no main roads for children to cross.

Lochside is predominantly an estate for older citizens, there can be not much more than 20 children who currently go to Greenbrae, so I see little benefit from rezoning. I understand Glashieburn has the capacity for 200 extra pupils, surely the Sheilhill area would be the obvious rezone.

Greenbrae School staff and pupils use our beautiful estate for outdoor activities, learning and cycling proficiency.

Many parents from Sheilhill drive to Greenbrae Primary, parking outside the homes in Lochside. So the Council is expecting children from Lochside to watch this happen, while they themselves have to walk to Glashieburn Primary which would entail a 15 minute walk for certain children, crossing a VERY busy Scotstown Road.

Greenbrae was extended in 2017, to deal with growing numbers in the Community. The new estate at Sheilhill had been granted planning permission and building works had begun by this time. It seems ludicrous by the Council NOT to have any foresight of the quantity of children a huge new residential estate would generate. It also seems ludicrous that the housebuilders were not asked to fund suitable provision for schooling which happens in Aberdeenshire areas.

Perhaps a Council red pen takes seconds to make a sweeping rezoning map on paper, but the impact of this change will never be justified to locals with such close proximity to Greenbrae School.

I would invite Councillors to visit the estate and see how close the School is. They perhaps should conduct a survey to see how many parents from Sheilhill DRIVE to school. Their journey would be about 2 mins more to drive to Glashieburn.

#### **11.11.22 – Comment**

To whom it may concern, unfortunately I do not see any positive outcome of the proposal to rezone Denmore park residents to Glashieburn primary school.

I have multiple concerns about this proposal.

Aberdeen city Council want to be seen as making a change to the environment and economy by becoming a greener city, but by rezoning the children from Denmore park/Lochside to Glashieburn you are promoting parents to take the car, In the morning it would be a 1-hour school drop off if parents were to walk. Which are we not trying to encourage parents to be at work hence the 11/40 provision at nursery? With the cost of living increasing some parents can no longer afford breakfast club & afterschool club, these areas of care come with very limited space anyway! So, an earlier drop off or later pick up is really not an option for all parents and not all employers are flexible to accommodate flexi working.

Rezoning would encourage and promote congestion around Jesmond Drive and put children at risk including the children from Oldmachar Academy trying to get to School. The Children at Denmore park would have to cross 1 VERY busy T junction and 5 other road openings this including the car park of Glashieburn before arriving to the school safely. Whereas the children of Denmore park can travel to School in an eco-friendly way and have their independence promoted at an earlier stage due to it being a safe and quiet route to school. Keeping the children of Denmore park & Lochside at Greenbrae allows parents to do the school drop off in the morning in a more calm and relaxed manner reducing the cars & congestion around the school area in "the mad hour rush" as the school is within walking distance, again PROMOTING a greener city! And allowing parents to be more flexible with their time and be there with their children on important transitions times, all because the Greenbrae school is so close to our homes.

Residents of Denmore park had to agree for Greenbrae to be extended, if the residents knew that this extension would land up not benefiting their children / grandchildren or future children then I feel that the outcome would have been rather different. Because of Denmore park the children of Greenbrae have access to lovely walks and outdoor learning experiences around the estate, the families of Denmore park support the school in as much ways as they can allowing the children of the school to get the best experiences and outcomes possible. I feel that you are taking away a huge part of Denmore parks & Greenbraes community link. If this is to go ahead Denmore park will become a drop off area for the parents of Sheilhill as Dubford road is already a joke of a road that can only fit 1 car past at a time due to the houses not having driveways and it being a bus route!! #### **14.11.22 – Comment**

I wish to formally object to the plan to rezone Denmore Park to Glashieburn School from Greenbrae School. My son, and the children of my neighbours were fortunate to be able to attend Greenbrae School. This meant my son could walk to School without having to cross any roads from a young age and all residents were able to walk to School with their Children. Given that the school actually has houses in Denmore Park that back onto the school or can actually see the school from their home I see no reason to accept that this move is anything but to cover the fact that the council has approved the building of additional housing without making the necessary provisions for schooling of the children in those areas. We are fortunate to have been able to send our children to Greenbrae and were safe in the knowledge that they did not have to cross any busy roads and the carbon footprint of those journeys were very low. I also wanted to object on the grounds that additional traffic will come into Denmore Park from the parents of children not from the estate to pickup their children from school as the housing being zoned to Greenbrae is much further away from the school



and so additional parents driving their children to and from school will be inevitable. Denmore Park roads are already suffering from a lack of maintenance and the increased traffic will no doubt have a further erosion of the roads and cause more damage to vehicles of residents who have to use these roads on a regular basis. There will also be additional traffic on Greenbrae Crescent which already is overloaded, suffers higher pollution and is dangerous for pupils who enter and exit the School. I feel the whole process has been badly handled by the council who surely were aware of the traffic issues around both Greenbrae and Glashieburn Schools and zoning children from new housing which is quite far away from either School. I am surprised that the council did not require that the provision of a new school building was required as part of the development plan for new housing at Shielhill, which is a 25 minute walk away (so you can expect most parents to drive rather than walk) rather than rezone housing that looks onto the school as a result of bad planning. Denmore Park has a long and close knit relationship with Greenbrae Primary and I am strongly opposed to giving that up for future residents of the estate. I would be interested to know the environmental impact of this decision and whether the council has seriously considered that before making this proposal.

### **19.12.22 – Comment**

Dear Sir,

I write with some dismay and incredulity about the planned re-zoning involving Greenbrae and Glashieburn primaries. I have copied in local councillors as I believe this planned re-zoning will go to a council meeting for a decision in March 2023.

I would ask council representatives to consider alternative solutions at an early stage so that the proposed plan is not presented as a "fait a complet."

As the crow flies it is a short distance from Denmore Park to Glashieburn and many secondary school pupils quite rightly make the further walk to Oldmachar Academy from Denmore estate. However to ask primary school children to walk along two busy roads and cross a hectic junction in rush hour traffic is less than ideal. A short cut through the local woods is NOT SAFE for primary school children. Parents are then most likely to use their car and add to traffic congestion while Greenbrae Primary is on their doorstep.

The traffic congestion is compounded by the fact a number of Greenbrae pupils residing north of the school (upper Dubford, Shielhill) have parents jump in their cars and drop off children in and around Lochside Road, within Denmore Park. (See photo)

While Denmore residents do not object to this parking (as long as a 20mph speed limit is observed) it will be nonsensical for Denmore Park children to be conveyed by car and drive past what has been their local primary school for some 40 years.

Indeed, currently in taking this journey to school by foot , cycle or scooter, they are promoting their own health and observing national guidance on reducing car journeys.

The pupil forecasts for each school in the next 6 years deserve some scrutiny.

Greenbrae present capacity 342 pupils

Only in 2027 and 2028 will the proposed re-zoning deliver the intention of achieving a capacity of < 342 pupils.

The capacity of Glashieburn school is 428 and over this six year projection the highest number of pupils will be 220 in 2024, less than 50% of school capacity.

There are further plans for Scotia to develop more homes in Shielhill, perhaps 500. Which school will these children attend? Although a new school is mentioned in the planning application, we know this is unlikely as such planning gain never materialises and it was immediately dismissed by school estate officials at the recent public meeting held at Greenbrae school.

These additional pupils with the proposed changes would be zoned for Greenbrae, but it again will be quickly over capacity by 2029.

The practical solution in a few years time will be to zone Shielhill pupils to the much under capacity Glashieburn.

This of course beggars the question why are Shielhill pupils not being considered for re-zoning NOW to Glashieburn ? - and as clearly pointed out already many of these children are driven to school, so it is a shorter journey to Glashieburn!

In the interest of childrens welfare, preserving a strong link to a LOCAL primary and saving the planet from unnecessary vehicle trips I ask the planners to reconsider their proposals.

I am writing to say that I oppose your plan to re-zone all of Denmore Park away from the local school – Greenbrae Primary School.

The school's own website says that the school opened in October 1977 and an extension added in January 2002.

It says that it is *"CENTRALLY placed to receive children from the housing estate of Greenbrae, Denmore Park, Dubford and Mariner's View"*.

The school is ideally placed for Denmore Park enabling children to walk to school easily and safely.

Why should the Denmore Park children have to go further afield and cross a main road to another school?

If you let more children living **outwith** Denmore Park attend Greenbrae Primary School then Lochside Road will be even busier with cars dropping off children. In addition, parents from Denmore Park will have to drive children to Glashieburn School. Lochside Road is currently in a very poor state due to existing potholes and we do not need any additional traffic.

We noticed an increase in cars on Lochside Road when you stopped cars from parking on Greenbrae Drive and the side roads there. You pushed the problem onto us!

Now we'll have more cars arriving and departing Denmore using the only entrance/exit onto a busy road called The Parkway which is a 40mph road. The cars arriving from **outwith** Denmore Park have engines running when dropping off or waiting to collect the children. What about 'air quality'?

I thought you encouraged 'safe routes' to school. What could be safer than children from Denmore being able to access the CENTRALLY placed Greenbrae Primary School on foot?
