#### How we use your information

#### How long we keep your information for

The application form and related documents will be retained by the Council's Licensing Team for a period of two years, from the date your taxi or private hire car licence expires. If your application is withdrawn or refused the application form and related documents will be retained for a period of two years from the date of withdrawal or refusal

#### Your Rights

#### **Our Legal Basis**

Wherever the Council processes personal data, we need to make sure we have a legal basis for doing so in data protection law.
