Statutory Consultation on Proposals (a) To close Glashieburn and Middleton Park Schools and establish an amalgamated school within the existing Glashieburn building and campus. (b) To vary the delineated (catchment) area of Middleton Park and Bucksburn Schools

As you may be aware, Aberdeen City Council is proposing to close Glashieburn and Middleton Park Schools and to establish a new amalgamated school within the existing Glashieburn building and campus.

The amalgamated school will accommodate all pupils in the current Glashieburn delineated area (catchment area) and those in the amended Middleton Park School catchment area.

Aberdeen City Council is proposing to vary the delineated area of Middleton Park School and the adjacent Brimmond School and Bucksburn Academy.

A period of Statutory Consultation commences on **26 August – 11 October, 2013** (inclusive), a total of 33 school days.

The period of public consultation must last a minimum of thirty school days.

In 2013, Monday 20 and 23 September are holidays when the schools will be closed and are therefore excluded contributing to the requisite number of days in the period of consultation.
