

Integrated Impact Assessment

The purpose of an Integrated Impact Assessment is to evidence that Aberdeen City Council is meeting its legislative duties by assessing the potential impacts of its policies and decisions on different groups of people and the environment. The legislation considered within this assessment is:

- Section 2 Equality Act 2010 protected characteristics
- Section 3 Socio-Economic
- Section 4 Consumer Duty
- Section 5 <u>Human Rights</u>
- Section 6 <u>Children and Young People's Rights</u>
- Section 7 Environmental impacts

The term 'policy' is used throughout this document and applies to policies, proposals, strategies, provision, criteria, functions, practice, budget savings and activities that includes delivery of our services.

1. About the Policy

1.1 Title

Further reduction to environmental services.

1.2 What does this policy seek to achieve?

The policy seeks a further reduction to environmental services.

This option proposes to further reduce environmental services, than was outlined in phase 1 of the consultation. This would stop or reduce cutting grass in cemeteries and open spaces, including parks. There would also be a further reduction of street cleansing, including stopping graffiti and chewing gum removal.

Grass cutting, and grounds maintenance across all open spaces stopped or reduced. Street sweeping would be reduced. Staff resources would reduce, and displaced staff may need to be added to the redeployment list with a view to searching for alternative employment within ACC. There would be a significant drop in service standards.

Grass cutting reduced across all areas Reduced amenity will see complaints rise significantly. There will be an increase to staff risk through hazards or items in long grass, reputational harm, reduced amenity.

Any change to programmes of work and cutting frequencies may need new equipment to meet the needs of the different work required. This would impact on the capital replacement of existing equipment and require other types of equipment for maintenance.

There would be a significant risk to the council's resilience and response to emergencies as the resources currently available to help with winter maintenance and flooding will not be available. Grounds staff focus on gritting pavements at sheltered housing and multi-stories would be reduced.

Support to in recovery from flood events would be severely restricted. Reduction in standards will see an increase in customer demand. Areas of play and leisure will be at risk as green spaces will not be suitable for sports or play.

Street sweeping is a statutory service. Staff resources would reduce and need to be redeployed, and this will increase demand on other street sweeping and litter picking teams. Risk of some areas receiving less street sweeping as remaining resources are moved into high profile areas, which may lead to more complaints and challenges on meeting cleanliness standards. There will be a reduction of SPIs and Service Standards.

Reduced street sweeping will impact significantly on flooding and gully emptying works. Significant risk in responding to severe weather events and a reduction in prevention (through reduced removal of leaves and other detritus) resulting in increased flooding incidents.

Impacts

2.2 In what way will the policy impact people with these protected characteristics?

Parks, green space and open spaces such as the beach, are very important to the people, including visitors, local residents and staff working in the area, especially for mental health and well-being. Parks and open spaces are seen as essential for people to enjoy nature, exercise, socialize, and escape from everyday problems.

Open spaces may not be so accessible to older people or disabled people.

Roads and pavements may be left longer before cleaning which will lead to a build-up of litter and debris. This may reduce accessibility to older people or disabled people.

2.3 What considerations have been made in reaching the above assessment?

Service data and budget information.

Aberdeen City Council has undertaken a public consultation around the 2025/26 Budget and future spending plans. Included in all parts of the consultation was a specific question regarding the further reduction in grass cutting, street sweeping and grounds maintenance.

Data from the budget consultation process has been reviewed and the option is clearly unpopular with the citizens of Aberdeen with the majority of people seeing it as having a high or medium impact.

There were no additional concerns for impacts on people with protected characteristics.

What consultation and engagement has been undertaken with officers and partner organisations? Internal engagement has taken place between a range of officers and Chief Officers in finance, legal and People and Organisation Development officers.

What consultation and engagement has been undertaken with people who may be impacted by this policy?

Aberdeen City Council undertook a two-part public consultation around the 2025/26 Budget and future spending plans from August 2024 to November 2024.

In Part 1, conducted throughout August 2024, participants were asked to provide feedback on four key areas: Budget Options, Council Tax, Service Area Prioritisation, and Capital Programme Expenditure. Under Budget Options, respondents were queried about the potential impacts of proposed options, including both reduction strategies and income-boosting charges. Regarding Council Tax, input was sought on acceptable levels of increase and their potential impacts. Citizens were also invited to

express their views on which service areas should be prioritised for spending and to offer their opinions on capital programme expenditure.

In part 2, which took place throughout November 2024, the Council consulted on additional budget options, again focusing on the impact if implemented. The phase 2 consultation included budget options relating to the Aberdeen Health and Social Care Partnership.

There were 4278 responses across the four areas consulted on during part 1 of the online consultation and 1535 responses to part 2. Respondents had the option to indicate which protected characteristics would be affected.

Various approaches were offered to support participation. Throughout both phases, opportunities were offered for the public to attend face to face and digital sessions to discuss the proposals in more detail. There were 2 face to face sessions, including British Sign Language options and 4 digital sessions, with a total of 24 attendees.'

Included in all parts of the consultation was a specific question regarding the further reduction in grass cutting, street sweeping and grounds maintenance.

Data from the budget consultation process has been reviewed and the option is clearly unpopular with the citizens of Aberdeen with the majority of people seeing it as having a high or medium impact.

Many people are worried that less street sweeping and grass cutting will increase hazards such as ticks, trip hazards and dog waste. Public health concerns were raised.

There was some support for reducing grass cutting and people suggest this would be good for biodiversity and the environment. People believe that reducing these services will make the city look unkept and less appealing to residents and visitors. This would see tourism impacted and this would have an impact on the local economy.

People see civic pride and moral being affected.
