Thank you for your information request of 8 August 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

Please see attached reports running from 16 January 2017 up until the present date, these are the full reports relating to inspections. The inspectors input their findings directly into the system while on site and this is how they are recorded. We hold no further information relating to inspections other than what is listed in the reports provided.

Also can you advise if the Adhoc inspections were carried out as a result of defects being reported by the general public via the council website.

Customer enquiries are logged onto our CRM system after being received either by a report on the website, by telephone, letter or in person. The Adhoc inspection on 1 February 2017 was carried out as a result of an enquiry made by members of the public and the Adhoc inspections on 13 February 2017 and 14 February 2017 were also carried out as a result of enquiries. Though these enquiries related to a different section of Kirk Brae, a full Adhoc inspection of the whole road was carried out on both dates. Please note that not all Adhoc inspections are as a result of enquiries.

Zurich Insurance says they have received a report from Aberdeen City Council on this incident, please supply a copy of this report.

Two reports were sent to Zurich relating to this incident. One of which was the inspection reports, which have been provided within this request. The other relates to the departmental report which includes personal information supplied by the claimant. This information cannot be released under an FOI request as it contains personal information and release under FOI/EIR would lead to the publication of that personal information.

ACC is unable to provide you with information on **a copy of the departmental report** as it is excepted from disclosure. In order to comply with its obligations under the terms of Regulation 13 of the EIRs, ACC hereby gives notice that we are refusing your request under the terms of Regulation 11(2) in conjunction with 11(3)(a)(i) – Personal Information - of the EIRs.

In making this decision ACC considered the following points:

ACC is of the opinion that Regulation 11(2) applies to the information specified above as the information in question is personal information relating to living individuals, and the applicant is not the data subject.

ACC is of the opinion that Regulation 11(3)(a)(i) applies, as ACC considers that disclosure of this information would be a breach of the first Data Protection Principle (that personal information must be processed fairly and lawfully). Third parties would not expect ACC to release this information about them into the public domain under the EIRs (or the Freedom of Information (Scotland) Act 2002 (FOISA)).

We hope this helps with your request.
