Thank you for your information request of 26 June 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

- 1) Please tell me how many food hygiene inspectors the council has had in its employ for each month since January 2014.**
- 2) Please provide your answers for every month since January 2014, up to and including the date of the receipt of this email.**

There are no officers with the job title of 'food hygiene inspectors' within Aberdeen City Council. Food Law Enforcement is undertaken by Officers within the Commercial Team of Environmental Health. This involves a mix of Environmental Health Officers, Senior Authorised Officers and Authorised Officers. The majority of officers within the team also have additional areas of responsibility e.g. health and safety, animal health and port health.
