Thank you for your information request of 26 July 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

Please could you tell me the management structure of the Education and Children's Services Directorate from the Director level down to Head Teacher level and include where the Music Coordinator fits in to the structure. It would be useful to have this in a tree diagram like format, including every management position, the numbers of those positions and I would like to know the salary scale associated with each post.

What I am interested to learn is who any Head Teacher's immediate superior is, who they report to and so on up to the Director of Education and also the same for the Music Coordinator. Also the Salary Scales associated with each post.

Please see attached structure charts. We do not hold charts detailing down to all levels of staff, however would advise that Head Teachers report to Quality Improvement Officers (QIOs) who in turn report to the Service Manager (Quality Improvement).
