Thank you for your information request of 4 August 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

**Cllr Claire Imrie register of interests seems to be short of information in 2 areas.**

**Election Expenses has been left blank rather than giving the answer 'none'. Are there expenses that should be disclosed?**

No further information is held by Aberdeen City Council in relation to this. Councillor Imrie did not submit any election expenses to ACC but I have been advised that she did submit information to the Returning Officer. The Returning Officer is a separate legal entity from ACC.
