In relation to 'sight of any written, electronic communication or photographic material', ACC is unable to provide you with this information as it is excepted from disclosure. In order to comply with its obligations under the terms of Regulation 13 of the EIRs, ACC hereby gives notice that we are refusing your request under the terms of Regulation 10(4)(b) — Manifestly Unreasonable - of the EIRs.

In making this decision ACC considered the following points:

This type of request would require the analysis of upwards of 1,674 winter advice and gritting logs, which would each be required to be redacted. In addition to this, upwards of twenty staff would then be required to perform email searches and every email regarding winter maintenance since January 2013 would then have to be printed and again redacted. As a minimum number, redaction of 1,674 documents would take up to 139 hours, which would be costed at £1,314.09 to complete, this is not including time spent searching and redacting emails, locating committee reports and online service plans.

There is only one person processing claims for the roads department as well as processing FOI requests. Both tasks are time sensitive. Collating the requested information would seriously impede officers ability to undertake other duties.

Under advice and assistance, we have provided you with the information above. We would also like to ask whether you would like to consider reducing the scope of your request. For example, is there any particular

year's Winter Service Plan you are most interested in or is there a particular area of Aberdeen that you are interested in i.e. gritting plans for a certain area of Aberdeen.

We hope this helps with your request.
