Thank you for your information request of 9 October 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

Please provide copies of all notes, working papers, meetings agendas and contents, briefings, emails, correspondence and all other written materials, together with audio and video recordings, from and to

The Scottish Government (including all personnel thereof) The UK Government, (including all personnel thereof) Aberdeenshire Council (including all personnel thereof), Aberdeen Football Club (including all personnel thereof), AFC Community Trust (including all personnel thereof), the Stewart Milne Group (including all subsidiary companies and personnel thereof), the Scottish Football Association (including all personnel thereof), the Scottish Professional Football League (including all personnel thereof), Burness Paul LLP , (including all personnel thereof), Halliday Fraser Munro (including all personnel thereof), Fairhurst UK (including all subsidiary partnerships and personnel thereof),

in relation to:

the Kingsford Stadium Planning Application by AFC Community Trust and Aberdeen Football Club plc and all related matters thereof.

ACC is unable to provide you with information on **copies of all notes, working papers, meetings agendas and contents, briefings, emails, correspondence and all other written materials, together with audio and video recordings, from and to The Scottish Government (including all personnel thereof) The UK Government, (including all personnel thereof) Aberdeenshire Council (including all personnel thereof), Aberdeen Football Club (including all personnel thereof), AFC Community Trust (including all personnel thereof), the Stewart Milne Group (including all subsidiary companies and personnel thereof), the Scottish Football Association (including all personnel thereof), the Scottish Professional Football League (including all personnel thereof), Burness Paul LLP , (including all personnel thereof), Halliday Fraser Munro (including all personnel thereof), Fairhurst UK (including all subsidiary partnerships and personnel thereof), in relation to the Kingsford Stadium Planning Application by AFC Community Trust and Aberdeen Football Club plc and all related matters thereof from 1 May 2016 to 7 October 2017.** as it is excepted from disclosure. In order to comply with its obligations under the terms of Regulation 13 of the EIRs, ACC hereby gives notice that we are refusing your request under the terms of Regulation 10(4)(b) – Manifestly Unreasonable - of the EIRs.

In making this decision ACC considered the following points:

A scoping exercise was undertaken in the areas identified in the request. It was identified that the scope of the request would cover all persons within 2 Directorates and multiple services. As such, every member of staff within those areas would have to search their correspondence for the words, 'Pittodrie', 'Kingsford', 'stadium' etc. These documents would need to be compiled, emails which were not relevant would need to be identified and deleted, and those left would need to be checked prior to release, removing any sensitive information such as personal information to avoid a breach of the data protection act.

The volume required to be undertaken is seen as excessive and will cause a detrimental effect on the day to day work of the officers involved in searching, extracting and compiling the information for release. This will mean that other ongoing, time sensitive projects will suffer delay. On this basis, ACC wish to refuse to respond to your request under the terms of Regulation 10(4)(b) – Manifestly Unreasonable – of the EIRS.

ACC would be happy to discuss ways in which you may refine your request, so we can provide some information of interest to you within the maximum cost limits. For example, by reducing the time period you are interested in, or by reducing the number of officers required to search (perhaps focusing on one team or one officer i.e. the relevant case officer for example).

It may also be helpful if you could clarify your request more specifically. This can be done by reducing the scope of the request or by providing us with keywords you would like us to search on. Please do contact the Information Compliance team, who will be happy to advise you, if this is something you would like to pursue.

Finally, I would like to mention that a significant amount of information regarding the Kingsford Stadium is published on our website, through our planning application portal which can be found here:
