Thank you for your information request of 31 October 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

How many call outs to environmental services were made to properties dealing with rats in your local authority area between September 2012 and September 2017? (Please break down per year as well)

Please see below:

1st September 2012 to 30th September 2013	120
1st October 2013 to 30th September 2014	109
1st October 2014 to 30th September 2015	157
1st October 2015 to 30th September 2016	161
1st October 2016 to 30th September 2017	198

Between Sept 2012 and September 2017, I would like to know the top ten roads/streets (with post codes) where rat call outs were made and the number of call outs for each of the ten streets. (Please break down per year as well)

Please refer to the attached table <u>EIR-17-1606 – Rats</u>. Please note that these streets vary in length and do not indicate potential areas of increased rat populations or reflect specific areas of concerns. They only list the number of complaints, some of which may not be justified.

How much was spent on dealing with rats between the 2012-2017 period? (Please break down per year as well, if possible)

Costs associated with the call out to rats complaints are incorporated with other costs associated with the provision of a pest control service within Aberdeen and cannot be quantified.
