Thank you for your information request of 15 November 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

I would be most grateful if you would provide me, under the Freedom of Information Act, details in respect of the attached framework agreement(s)/contract(s):

a) Suppliers who applied for inclusion on each framework/contract and were successful & not successful at the PQQ & ITT stages.

This was an open tender so there was no PQQ stage. One supplier submitted a bid when the Invitation to Tender was advertised – Morning Lane Associates. They were successful.
