Thank you for your information request of 24 November 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

I am requesting information under the freedom of information act. could you please provide information as following?

1. does your local authority use a bespoke IT software system to record/manage social care activities i.e. case management system for adult & children services ?

Yes, we use a bespoke IT software system.

2. if no, is there ongoing planning to purchase a bespoke software system or develop in house system in the near future?

Not applicable – see answer to Question 1

3. Describe the brief information of the current software system in use?

Aberdeen City use a modular software system covering all aspects of statutory Social Work requirements in Adults, Children's, Criminal Justice and Service provision.

4. what is the product name of the current software system and which company is it purchased or contracted from?

Aberdeen City Council use CareFirst supplied by OLM Systems Ltd.

5. is this software system purchased outrightly or if on contractual basis what is the expiry date of the contract? specify details.

The CareFirst System is contracted with current contract to end on 31 March 2020.

**6.** what was the total capital cost of purchasing or developing this software system ? There is a Contracted annual payment until 31 March 2020.

**7.** What are the ongoing development and maintenance costs since purchase (annually)? Annual maintenance cost is currently £175,000.

Unfortunately, we are unable to break this down further or provide you with ongoing development costs. OLM Systems Ltd invoice us for payment for a number of items, not just CareFirst and not just ongoing development and maintenance costs. These invoices are not separated or recorded in such a way as to allow us to compile this information for you without extracting and investigating all invoices received since purchase, collating the relevant information where noted.

As you can imagine, this is a significant task and would likely exceed the £600 threshold for FOISA compliance. As such, ACC are unable to provide you with this information as requested.
