Thank you for your information request of 30 October 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

How many appeals have been made against contravention at same location in same timeframe.

ACC stats show only the appeals received from September 2016 to date which are 734. This is because the system does not have the facility to input a date range.
