Thank you for your information request of 12 August 2019. Aberdeen City Council (ACC) has completed the necessary search for the information requested. Our response is now detailed below.

I am conducting academic research into sexual entertainment, and specifically the regulation of the same through the Licensing (Scotland) act 2005 and the Civic Government (Scotland) Act 1982. I would be obliged if you could provide the following:

### Question 1

- a. Confirmation of numbers and details of premises (i.e. what premises are they?) with "Adult Entertainment" currently selected as Yes on the liquor licence operating plan.
- b. Confirmation of total numbers and details of premises (i.e. what premises were they?) with "Adult Entertainment" formerly selected as Yes on the liquor licence operating plan.
