Thin Surfacing Micro Surfacing Surface Dressing

Please note all the above mentioned treatment are important for asset management, however, micro surfacing does not seem to provide a long term solution.

High Friction Surfacing: <5%

Jet Patching: <5-10% Thermal Patching: <5%

The main treatments used are either thin surfacing overlays and inlays, <150mm overlays or inlays and surface dressing. Other treatments used for specific sites and projects as required.
