The figures replaced with \*\* cannot be provided as it relates to numbers greater than 0 but less than or equal to 5 which could be misleading or lead to identification of an individual.

We are unable to provide you with the exact figures where \*\* has been used, as it is exempt from disclosure. In order to comply with our obligations under the terms of Section 16 of the FOISA, we hereby give notice that we are refusing your request under the terms of Section 38(1)(b) in conjunction with Section 38(2)(A)(a) – Personal Information - of the FOISA.

In making this decision we considered the following points:

We are of the opinion that Section 38(1)(b) applies to the information specified above as the information in question is personal information relating to living individuals, of which the applicant is not the data subject.

We are of the opinion that Section 38(2A)(a) applies, as we consider that disclosure of this information would be a breach of the 'lawfulness, fairness and transparency' principle. As releasing these details would enable other people to identify these individuals. These individuals have not consented to the disclosure of their information, and we do not consider that they would expect us to release this information about them into the public domain under the FOISA.

## 2. How many of them have gone on to the positive destinations as specified by the Scottish Government.
