Thank you for your information request of 20 December 2016. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

We make a request under the Freedom of Information Act pertaining to a property on Nelson Street, Aberdeen. We would be most grateful if you could provide the following;

- All records (electronic and paper) logs and notes showing the dates the property was inspected by you or someone acting on your behalf from 1 December 2006 and 1 December 2016.
- 2) All records (electronic and paper), logs, notes, receipts and invoices showing all planned and/or completed maintenance work to the property windows (including but not limited to the window frames panes and locks) from 1 December 2006 and 1 December 2016.

Please find attached a copy of the inspection report for Nelson Street Aberdeen. We do not hold records prior to February 2008. Therefore, ACC is unable to provide you with this information as it is not held by the Council. In order to comply with its obligations under the terms of Regulation 10(4)(a) - Information Not Held - of the EIRs, ACC hereby gives notice that this information is not held by it. ACC is required by Regulation 10(1)(b) of the EIRs to inform you as to why in all the circumstances of the case, the public interest in maintaining this exception outweighs the public interest in disclosing this information to you. ACC is satisfied that it does not hold this information and considers that, as there is no information held, the public interest lies with the exception.

Third party names and personal details, as well as the names of ACC Officers who are below Head of Service level have been redacted (blacked out) from the attached correspondence. This is because ACC considers that this information is exempted from disclosure. In order to comply with its obligations under the terms of Regulation 13 of the EIRs, ACC hereby give notice that we are refusing your request under the terms of Regulation 11(2) in conjunction with Regulation 11(3)(a)(i) – Personal Information – of the EIRs.

In making this decision ACC considered the following points:

ACC is of the opinion that Regulation 11(2) applies to the information specified above as the information in question is personal information relating to living individuals, and the applicant is not the data subject.

ACC is of the opinion that Regulation 11(3)(a)(i) applies, as ACC considers that disclosure of this information would be a breach of the first Data Protection Principle (that personal information must be processed fairly and lawfully). Third parties named within the attached document and ACC Officers below Head of Service level would not expect ACC to release this information about

them into the public domain under the EIRs (or the Freedom of Information (Scotland) Act 2002.
