Thank you for your information request of 14 March 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

## Voluntary closures

Please see the attached list. The grey fields relate to premises which have subsequently become vacant who are under new ownership since the voluntary closure was undertaken. Details of three establishments subject to ongoing enforcement action have been redacted.

ACC is unable to provide you with information relating to these three voluntary closures as this information is considered exempt from disclosure under Section 10 (5) (b) –The Course of Justice - Environmental Information (Scotland) Regulations 2004.

Reports relating to these voluntary closures have been submitted to the Procurator Fiscal in relation to the establishments and any disclosure of this information may impact upon the administration of justice.

I recognise that there is a public interest in the release of this information as it would allow the public to make informed choices before using certain

establishments; however it is not in the public interest for ACC to release information before investigations are concluded. If details of the closure were already in the public domain prior to any court proceedings then this has the potential to prejudice any case taken by the Procurator Fiscal.

Having considered both parts of the public interest test, I appreciate that there is a significant public interest in ensuring transparency and accountability of ACC's functions; however, this is overshadowed by the need to ensure that ongoing and future investigations are not impeded.

Information regarding non-compliant businesses is routinely published through the Food Hygiene Information Scheme, where non-compliant businesses are classified as 'Improvement Required'. Therefore information permitting consumers to make an informed choice is already available without the potential to impact on the administration of justice.
