Thank you for your information request of 21 June 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

In order to assist with our investigations, we request the following information under the Freedom of Information (Scotland) Act 2002;

 Copies of all reports, documents, correspondence or communications confirming the traffic light sequence in place at the junction between Dyce Drive and Argyll Road, Aberdeen on 23 February 2016.

We can advise that up until 10:30am and after 3:30pm on 23 February 2016 the permanent traffic signals at this junction were operational and running the following stage sequence;

Stage 1 - Traffic travelling east and westbound on Dyce Drive received a green light, with all remaining traffic movements held on a red light.

Stage 2 – Traffic travelling westbound on Dyce Drive continued to see a green light but with the addition of a green right turn indicative arrow, the green arrow advised drivers that opposing traffic is being shown a red light. Traffic wishing to turn left from Argyll Road onto Dyce Drive received a left turn filter arrow, with right turning traffic continuing to be held on a red light.

It should be noted that Stage 2 was demand dependant and would only appear if traffic wishing to turn right from Dyce Drive into Argyll Road had moved onto the junction and entered a demand with the signal controller but has been unable to complete the manoeuvre by oncoming traffic.

Stage 4 – Traffic travelling southbound on Argyll Road now receives a full green light, with all remaining traffic movements held on a red light.

Temporary traffic signals were than operational between 10:30am and 3:30pm with all 3 arms of this junction, Dyce Drive eastbound, Dyce Drive westbound and Argyll Road receiving a green light individually.

2. Copies of all reports, documents, correspondence or communications confirming details of the sequencing relating to all filter lights at the junction between Dyce Drive and Argyll Road, Aberdeen, on 23 February 2016.

Please see the description above relating to Stage 2 of the permanent traffic signal sequence for details of the right turn indicative and left turn filter arrows.

3. Copies of all reports, documents, correspondence or communications confirming details of any temporary traffic lights in place at the junction between Dyce Drive and Argyll Road on 23 February 2015.
There were no temporary traffic signals in place at this junction on 23rd February 2015.
