## Could you please provide me with some planning and spend information from your Council:

- Estimated future spend on building new schools and nursery buildings including new extensions to existing sites for period 2017-18 to 2021-22, for each year individually.

### 2017/18

Existing Projects – Total anticipated spend: £39.6m

#### 2018/19

Existing Projects – Total anticipated spend: £5.5m

### 2018-22\*

Future Projects (estimated costs only) – Total anticipated spend: £110m

# - What forms of contract do you typically utilise for these contracts such as NEC3, SBCC Design and Build etc?

This varies for each project although we are doing more NEC3 now whereas projects used to be done more under SBCC in the past.

- What different methods of procurement do you utilise to build new schools and nurseries (including school and nursery extensions).

Within ACC we typically undertake individual tenders following the restricted route although we may consider a main contractor framework in the future with all such builds being undertaken via suppliers on this framework. Similarly, we will also consider other national frameworks such as SCAPE. There is no 'one size' answer with the route being decided as to what best suits each particular project.
