Thank you for your information request of 27 February 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

Please provide

- 1. The total value of business rates (NNDR) owed to the authority in each year
- 2. The total number of businesses owing rates to the authority in each year
- 3. The value of (1) written off as unrecoverable in each year
- 4. The total value of business rates successfully collected in each year
- 5. The largest sum owed by any single business in each year

6. The trading name and company number of the business owing the largest amount in each year

ACC is unable to provide you with information on **The trading name and company number of the business owing the largest amount in each year** as it is exempt from disclosure. In order to comply with its obligations under the terms of Section 16 of the FOISA, ACC hereby gives notice that we are refusing your request under the terms of Section 33(1)(b) – Commercial Interests and the Economy - of the FOISA.

In making this decision ACC considered the following points:

ACC cannot publish or release details of business rate arrears or debit balances. Public authorities owe taxpayers a duty of confidentiality which protects tax arrangements from release to the public. This exists in part to prevent prejudice to the commercial interests of taxpayers. If ACC were to publish arrears or debit balances this may lead to questions about the solvency of the trader or company and issues with suppliers and customers. ACC could then open itself up to legal action and claims.

In relation to arrears, we could only consider publishing details at the stage where court action

has been raised and a decree obtained – for example where details are published in the Edinburgh Gazette. ACC does not routinely publish details of Business Rates arrears using this medium; recovery of outstanding rates is a matter between ACC and the defaulting ratepayer and in terms of recovery action initiated in terms of current rating statute.

We hope this helps with your request.
