## 1. The number of Council Tax accounts in arrears

The details below indicate the number of Council Tax accounts in arrears which progressed through the different stages of recovery.

It should be noted that where there is more than one liable person named on a Council tax account, separate documentation must be issued for reminders, finals and broken arrangement letters.

Where the account progresses to Warrant Petition, Warrant Granted and Sheriff Officer, the lists indicate all liable person(s) names pertaining to the account as one entry i.e. husband and wife who are jointly liable will have received separate reminders but will only appear once on the list pertaining to the financial year.

However, there can also be separate entries on the lists for more than one financial years' outstanding Council Tax which should also be taken into account in the figures.
