Thank you for your information request of 21 April 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

I am attaching a spreadsheet with 43 staff members of Aberdeen Council listed. Please can you populate columns D and E with the direct telephone numbers and email addresses? Additionally if someone has been replaced can you add the correct person's details?

Please see the attached spreadsheet for information relating to your request.

ACC is unable to provide you with details of officers below Service Manager level as it is exempt from disclosure. In order to comply with its obligations under the terms of Section 16 of the FOISA, ACC hereby gives notice that we are refusing your request under the terms of Section 38(1)(b) in conjunction with Section 38(2)(a)(i) - Personal Information - of the FOISA.

In making this decision ACC considered the following points:

ACC is of the opinion that Section 38(1)(b) applies to the information specified above as the information in question is personal information relating to living individuals, of which the applicant is not the data subject.

ACC is of the opinion that Section 38(2)(a)(i) applies, as we consider that disclosure of this information would be a breach of the first Data Protection Principle (that personal information must be processed fairly and lawfully). The individual, who is below Head of Service level, has not consented to the disclosure of their information, and ACC does not consider that they would expect ACC to release this information about them into the public domain under the FOISA.
