Thank you for your information request of 8 May 2017. Aberdeen City Council (ACC) has completed the necessary search for the information requested.

Please can I receive a full set of plans/maps showing the locations of the ground originally called the Lands of Torry which I understand are overseen by the Guildry and Mortification Board,

Please see attached a copy plan showing the area of ground coloured red, which was originally taken in the name of the Master of Mortifications, is vested in Aberdeen City Council and any income from it is now paid to the "Lands of Torry" a charitable fund of which Aberdeen City Council is trustee.

As you will see from the plan, the boundary of the area is uncertain and no more exact descriptions or plans can be located.

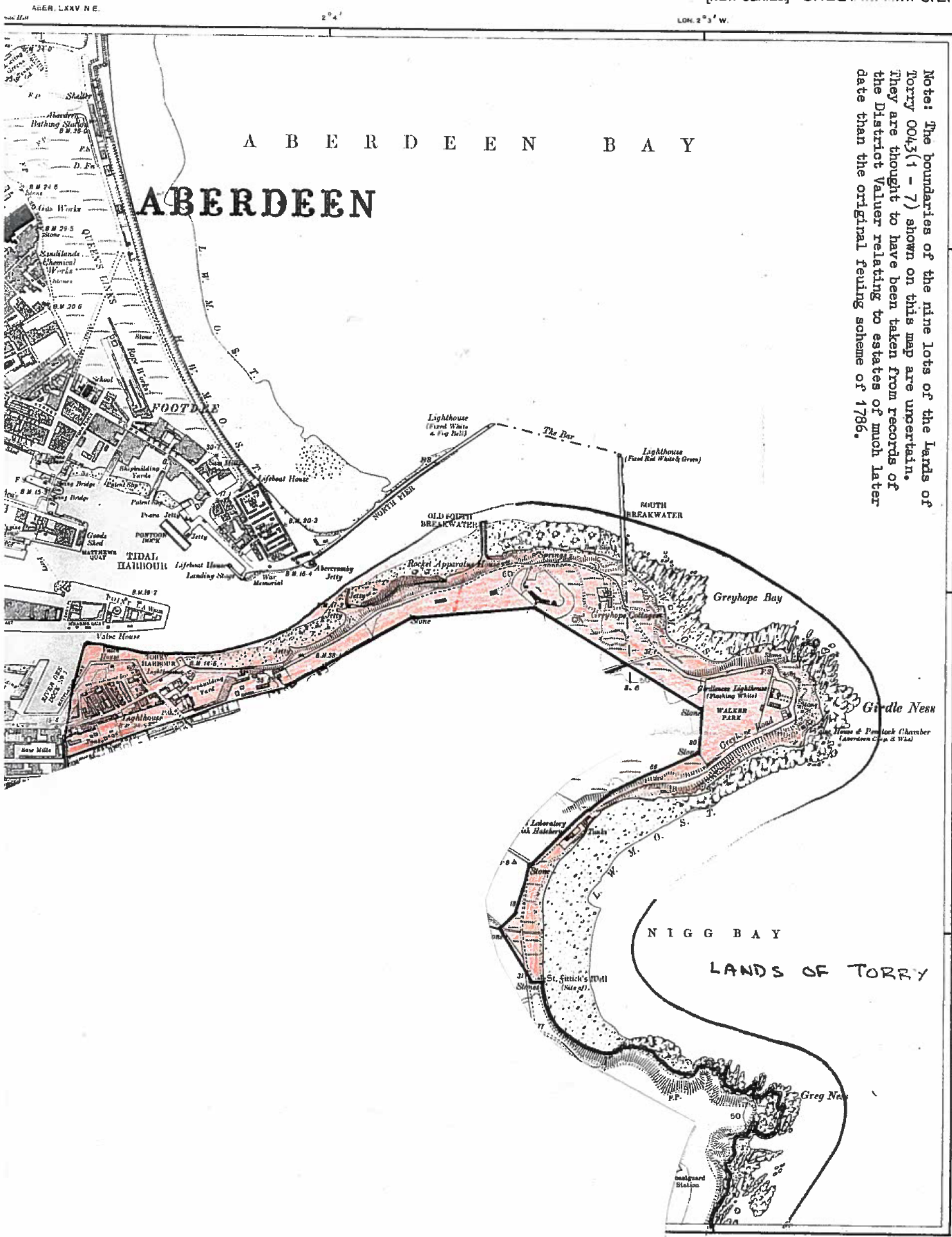

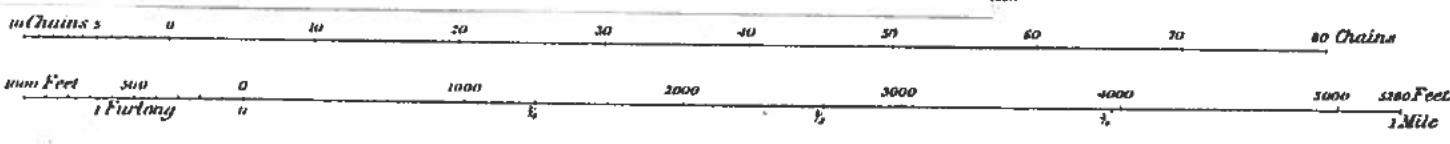
