What would you like to say about the issue?

I wish to object to the proposed building of 8 homes at site OP108 - Mid Anguston.

Mid Anguston is about 2 miles from the nearest amenities in Peterculter which will result in these home owners having to use cars as a means of transport. The Transport Plan aims to reduce car usage and this does not achieve this. There are no pavements from Mid Anguston to Peterculter and no street lighting. There is no public transport until you reach the main Banchory Road.

The existing Mid Anguston - Peterculter Road is already narrow and in poor condition. Additional car usage will simply cause further deterioration.

The building of 8 homes will impact greatly on the views at Mid Anguston and new build homes will not fit well with the existing homes in the area.

What change would you like to see made?

Remove OP108 - Mid Anguston from the plan. Reject the planning application for 8 homes in this area.
